Campbell is the Founder and Director of Incident Response Solutions Limited, providing forensic, cyber security and crisis management services.

Campbell was previously a Director at PwC New Zealand (12 years). Campbell led PwC's national "forensic technology" practice, and the Auckland "cyber security" practice, a combined team of 11 expert staff. Prior to PwC, Campbell was a founding member of NZ Police's Electronic Crime Laboratory (4.5 years).

As an expert witness, he specialises in electronic investigations, cybercrime incident response and eDiscovery matters. He is recognised by the District and High Courts of New Zealand as a forensic technology expert and has also been appointed as an independent expert by the High Court.

Campbell has worked on a wide range of forensic and cyber matters for both the private and public sectors including:

Forensic Technology
